Public Hearing for 2025 Tentative Budget

MINUTES OF THE ASHLEY VALLEY SEWER MANAGEMENT BOARD

The Public Hearing for 2025 Tentative Budget meeting was held Tuesday November 12, 2024 at 5:00 p.m. at the Vernal City Office. Board Members present were Chairman Richard Jolley, Max Haslem, Randel Mills, Corey Foley, Boyd Workman, and Nolan Jackson. Employees in attendance were Dean Gibbs and Amiee Peterson.

Chairman, Richard Jolley, called the meeting to order at 5:00 p.m.

Public Hearing for 2025 Tentative Budget Called to Order:

Richard Jolley Chairman called the 2025 Tentative Budget public hearing to order.

Operating & Non-Operating Revenues:

Manager's Presentation of Tentative Budget:

Dean Gibbs reviewed the Operating & Non-Operating Revenues for the 2025 Tentative Budget. Dean Gibbs discussed a change in waste hauler rates. The rates would change from \$.088 per gallon and 85% of the truck capacity to \$0.10 per gallon and 80% of the truck capacity. Dean Gibbs stated that would be a 6.5% increase overall. Dean Gibbs stated that he would like to adjust the Waste Hauler Permitting Fee to \$150.00 for a new permit the first year with a \$75 annual renewal fee. Dean Gibbs stated the existing permitted haulers will see their renewal fee decreased to \$75 also. Dean Gibbs reviewed the new sewer user rates that were adopted in May of 2024 that will be in place as of January 1, 2025, and are included in the 2025 Tentative Budget Revenue.

Expenses: Dean Gibbs reviewed the estimated Operating Expenses, Debt Expenses, and Capital Project Expenses included in the 2025 Tentative Budget with the Board.

Board Discussion on Tentative Budget: The Board reviewed and discussed the 2025 Tentative Budget as presented.
